## 20. NOMINATIONS FOR COMMITTEE MEMBERS.

- 20.1 Nominations are required for the following Committee Members:
  - 20.1.1 President
  - 20.1.2 Commodore
  - 20.1.3 Treasurer
  - 20.1.4 Rear - Commodore Social
- 20.2
  - 20.2.1 To be eligible for election to the Main Committee, the candidate must have at least been a recent member of the Club for a minimum of two (2) years.
  - 20.2.2 To be eligible for election to serve as President or Commodore, the candidate must have served for at least two (2) full term years on the Main Committee
- 20.3 Not later than 15 July of each year the General Committee shall cause a notice calling for nominations for the Committee Members listed under 20.1.1 to 20.1.4 to be posted on the Club Notice Board and mailed to all the Ordinary members. Nominations for these Committee members shall be in writing, shall be signed by the Nominator, Secunder and the Nominee and shall be lodged with the Secretary or Manager of the Club not less than sixteen(16) days prior to the AGM at which the election is to take place. All nominations shall be displayed on the Club Notice Board for not less than fourteen days prior to the said AGM. Only Ordinary Members and Honorary Life Members shall be eligible to nominate or second Committee Members.
- 20.4 Elections at the AGM of nominated Committee Members shall be by means of prepared voting slips and the Member shall mark upon the voting paper a cross against the name of the candidates for whom he intends to vote
- 20.5 If additional members are not nominated to serve on the committee, the General Committee may co-opt members for such position if needed.
- 20.6 Rear-commodore for Sailing, Boating, Moorings and Diving are elected by their respective sections prior to the AGM and thereby automatically become members of the General Committee.
- 20.7 The Coordinators for Safety and Development are elected by their respective committees prior to the AGM and thereby automatically become members of the Main Committee..
